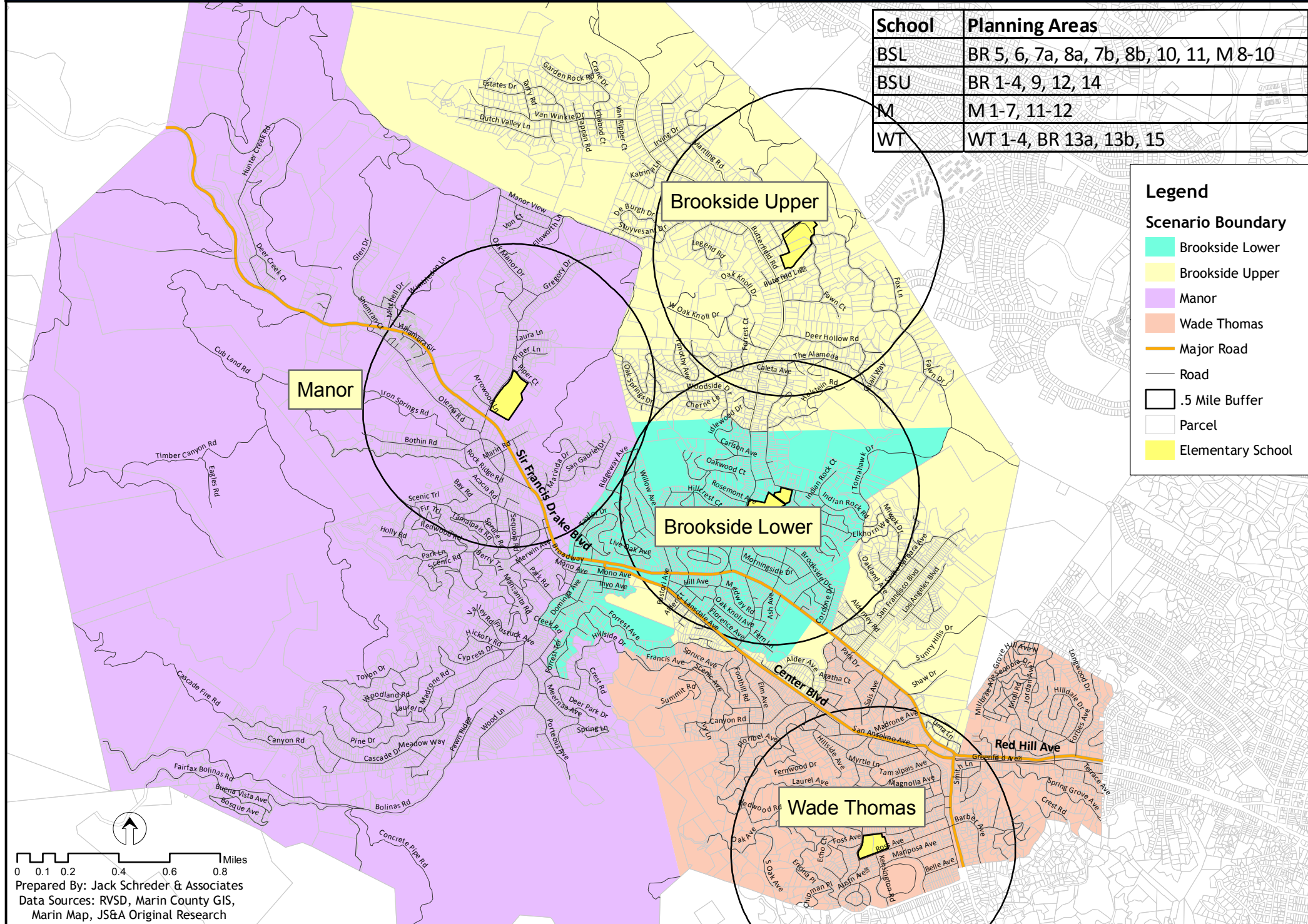

Measurement against Board Criteria

- **Create and maintain four independent K-5 schools of similar size.**
 - Total Residents varies by a maximum of 134 students.
 - Projected Enrollments varies by a maximum of 56 students.
- **Prioritize enrollment for residents who live closest to a school site and within its boundary, taking into consideration natural geographic boundaries, to enable and encourage walking and biking to school and to minimize the number of people traveling by car.**
 - See map. Portions of Brookside that fall within the Brookside Lower .5 mile buffer are assigned to Brookside Upper (approx. 61 residents).
- **Aligns with Safe Routes to School for students who walk or bike to school.**
 - Needs further assessment.
- **Maintains accessibility to District-wide programs (e.g. MAP and the Learning Center).**
 - Meets criteria.
- **Minimizes the number of current students who must change schools during the transition phase as a result of these boundary adjustments.**
 - It is the District's intention that no current students must change schools as a result of these boundary adjustments. It is also the District's intention to make allowances for younger siblings.
 - Incoming kindergarten students affected by boundary change in 2011-12:
 - From Manor to Brookside Lower = 7
 - From Brookside Lower to Wade Thomas = 14
 - Since Brookside enrollments are dependent on implementation plan, we calculate the total number of residents assigned:
 - To Brookside Lower = 381
 - To Brookside Upper = 295
