Item D1 is: "Discussion on Including Additional Detail in Minutes and Report from the RVSD 7-11 Advisory Committee to the Board."

As I mentioned in public comments time last week regarding approval of the minutes from the meeting of April 17, the minutes that were then approved by the 7-11 Committee do not contain sufficient detail to be an adequate records of a meeting that was billed as a "public input meeting".

The meeting had only one agenda item: "Public Input Session Regarding 199 Porteous Avenue, Fairfax". The minutes of the meeting that were approved on April 24 say only "The Committee heard public input from 37 community members." That is not much of a record of a one item meeting expressly called to solicit community input.

Committee member Max Edwards suggested the minutes be amended to reflect at least the a sense that the bulk of the 37 comments reflected one thing - continued use of Deer Park for FSACC. Business Manager Chris Carson and paid consultant Bryce Chastain commented that minutes are "facts" reflective of what happened in a meeting, not later reflections on the meeting. That is true, but minutes are also not supposed to be an obfuscation of what actually happened in a meeting.

In what I found a particularly galling response, not one person rose to second Max Edwards motion to simply add that the majority of the input favored the continued use of the property by FSACC and the motion thus could not advance. Then the committee voted to approve the minutes, with Max Edwards voting no.

It doesn't seem that anything can be done about the lame minutes from April 17 that have been approved. I do request that both the 7-11 Committee and the RVSD Board be more attentive to detail when creating enduring records of their work.

Subject: Priorities missing in 7-11 committee May 1 draft report

I am attending a professional conference out of town and wanted to make sure that my comments get to the committee.

#### Education Code section 17390 requires a 7-11 Committee to do all of the following:

- Review the projected school enrollment and other data as provided by the district to determine the amount of surplus space and real property.
- Establish a priority list of use of surplus space and real property that will be acceptable to the community.
- Cause to have circulated throughout the attendance area a priority list of surplus space and real
  property and provide for hearings of community input to the committee on acceptable uses of space
  and real property, including the sale or lease of surplus real property for child care development
  purposes pursuant to Section 17458.
- Make a final determination of limits of tolerance of use of space and real property.
- Forward to the district governing board a report recommending uses of surplus space and real property.

Nowhere in the May 1 draft report is a clear priority list of use of the Deer Park space acceptable to the community found.

The findings listed in the report are clear:

"The overwhelming majority of public input received from public comment during regular 7-11 Committee meetings, vocal support at the public input meeting, and written public input throughout the process (all of which is included with this report in the minutes and appendices), supports the Fairfax San Anselmo Children's Center (FSACC) at the Deer Park School Site. Considering and consistent with this overwhelming and consistent public support, the Committee supports the sale, lease, or land transfer of the Deer Park School site in a manner that facilitates the continued operation of FSACC onsite."

Yet the report only includes tolerable and intolerable uses as recommendations. The tolerable uses are not indicated as reflecting priorities, so where is that part of the Ed Code requirement clearly addressed?

After hearing public input at the 7-11 Committee meeting designated as a public input session (though no specific records of the input were officially kept) and reviewing the written submissions, it is clear that the community preferred use is to have FSACC at the Deer Park site. That clear community guidance should be listed in the final report as top priority.

I appreciate the inclusion of "childcare and early childhood education services that foster diversity and that support low- and middle-income families in Marin County" in the recommendations but I

feel that statement deliberately disguises the true sentiments of the community as clearly expressed to the 7-11 Committee.

I am requesting that there be a clear list of priorities that is reflective of community input and that FSACC be specifically identified as per the community input.
