

**Ross Valley School District  
Unaudited Actuals Financial Report  
2013-14**

Staff has completed closing the districts books for the 2013-14 fiscal year. The General Fund ending balance has increased above projected amounts, while other funds have increased as well.

**General Fund**

The General Fund ending balance has decreased, but by \$1.54M less than estimated amounts at budget adoption, decreasing by (\$399,000) instead of (\$1,945,000). Of this amount, \$837k of budget savings is from unrestricted resources and \$709,000 from restricted resources. The details of the changes are identified on the schedules attached and below. These amounts will be carried over to the 2014-15 budget in the form of fund balance and allocated as per direction of the Board of Trustees. The ending fund balance has been allocated as per the attached SACS form, and listed below.



The **Deferred Maintenance Fund** was reestablished, as discussed with the Board in August, due to the transfer of the remaining deferred maintenance dollars that had been tracked in the general fund back to the Deferred Maintenance Fund 14. Rather than assigning, or setting aside this balance at each reporting period, the tracking of deferred maintenance expenditures and transfers to fund the program, will now be identified separately by fund.

The **Building Fund** is used to track the proceeds of bond issues and includes the proceeds from the \$5.44M Bond Anticipation Note issuance in December, plus the expenditure of \$6.8M of capital expenditures on White Hill and Brookside.




**Part IV - Carry-forward Adjustment**

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates the need for LEAs to file amended federal reports when their actual indirect costs vary from the estimated indirect costs on which the approved rate was based.
